

PUBLIC OFFER

about making a charitable donation

By making a charitable donation, the Benefactor confirms that he has read the terms of this Offer, understands them and unconditionally agrees to them.

1. General provisions

1.1. This Public Offer (hereinafter referred to as the "Offer") is a public offer of the CHARITY ORGANIZATION "REPOWER UKRAINE FOUNDATION" (hereinafter referred to as the "Foundation") to conclude an agreement on the provision of a charitable donation with any capable individual or legal entity (hereinafter referred to as the "Benefactor") on the terms set out below.

1.2. The offer is prepared in accordance with the Civil Code of Ukraine, the laws of Ukraine "On Charitable Activities and Charitable Organizations", "On Electronic Commerce", other regulatory legal acts of Ukraine and the Charter of the Foundation.

1.3. The Agreement is concluded by the Benefactor joining this Offer without the parties signing a separate written copy.

1.4. Acceptance of the Offer is the Benefactor's action aimed at transferring the charitable donation: payment on the Foundation's website through an available payment service or transfer of funds to the Foundation's bank account.

1.5. The date of conclusion of the contract and the date of donation is the date of crediting the funds to the Fund's bank account.

2. Subject of the contract

2.1. The benefactor voluntarily and free of charge transfers funds to the Foundation as a charitable donation, and the Foundation accepts the donation and uses it to achieve the goals and implement the areas of charitable activity defined by the Foundation's Charter, charitable programs and the legislation of Ukraine.

2.2. The donation is not payment for goods, works or services and does not create an obligation for the Foundation to provide the Benefactor with any material or non-material compensation.

2.3. A donation is considered to be provided for the implementation of the statutory activities of the Foundation.

3. Amount and procedure for making a donation

3.1. The Benefactor determines the amount of the donation independently, taking into account the technical capabilities of the selected payment method.

3.2. Donations are made through the payment page on the Foundation's website using available payment methods or by bank transfer using the Foundation's details. The donor can use a payment card or bank account opened in hryvnia or foreign currency.

3.3. If the payment is initiated from a card or account in a foreign currency, the conversion is carried out by the Benefactor's bank, the acquiring bank and/or the payment service in accordance with their rules and the exchange rate in effect at the time of the transaction. The funds are credited to the Foundation's bank account in hryvnia.

3.4. For the purposes of accounting and using a donation, its amount is determined as the amount in hryvnias actually credited to the Fund's bank account after conversion.

3.5. The Foundation does not set or control the exchange rate, conversion procedure, bank fees or other charges applied by the Benefactor's bank, acquiring bank or payment service. As a result of conversion and collection of fees, the amount debited from the Benefactor's account in foreign currency may differ from the hryvnia equivalent credited to the Foundation.

4. Rights and obligations of the parties

4.1. The Foundation undertakes to use the donations received in accordance with this Offer, the Charter, charitable programs and the legislation of Ukraine.

4.2. The Foundation has the right to independently determine the directions, priority and methods of using donations within the framework of its statutory activities.

4.3. The Benefactor has the right to receive publicly available information about the activities of the Foundation and the use of charitable donations within the limits established by law.

4.4. By making a payment, the Benefactor confirms that he has the necessary civil capacity and the right to dispose of the funds and that the donation is made voluntarily, without coercion and without expectation of a return.

5. Irrevocability of donations and refunds

5.1. A charitable donation is voluntary, free of charge and non-refundable. Once the funds are credited to the Fund's account, the donation is non-refundable.

6. Liability and force majeure

6.1. The Parties are liable for failure to fulfill or improper fulfillment of obligations in accordance with the legislation of Ukraine.

6.2. The Fund is not responsible for the temporary inability to make a payment caused by the work of banks, payment services, telecommunications operators, technical failures or force majeure circumstances beyond the reasonable control of the Fund.

7. Personal data

7.1. By making a donation and providing personal data, the Benefactor agrees to their processing by the Foundation to the extent necessary for accepting and accounting for the donation, communicating with the Benefactor, fulfilling the requirements of the law, and implementing the Foundation's statutory activities.

7.2. Personal data is processed in accordance with the Law of Ukraine "On Personal Data Protection" and the Foundation's privacy policy.

7.3. Payment card details are processed by the bank and/or payment service. The Fund does not receive or store full payment card details, unless otherwise expressly provided for by the selected payment method and legislation.

8. Validity period and change of conditions of the Offer

8.1. The offer comes into force from the date of its posting on the Fund's website and is valid until its withdrawal or replacement with a new version.

8.2. The Foundation has the right to make changes to the Offer. The version valid at the time of its implementation shall apply to the donation.

8.3. The invalidity of a separate provision of the Offer does not entail the invalidity of its other provisions.

8.4. Issues not regulated by this Offer are governed by the legislation of Ukraine.
